Pursuant to the provisions of Florida Statutes, DRAIN DOCTORS INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation.

**ARTICLE I**  
**Name**

The name of the Corporation is Drain Doctors Inc. The date of filing of the Articles of Incorporation was March 11, 2003, Charter Number H03000772837.

**ARTICLE II**  
**Amendment**

The text of the amendment to the Articles of Incorporation is:

Article IV of the Articles of Incorporation is hereby amended to change the number of shares the Corporation is authorized to issue from 1,500 shares with a par value of \$.10, to 10,000 shares with a par value of \$.10 effective December 21, 2006.
