ARTICLE ONE

NAME

The name of this corporation is:

ABOVE ALL CONSTRUCTION, INC.

The principal place of business of this corporation shall be 7710 S.W. 18th Terrace, Miami, Florida 33155.

NATURE OF BUSINESS
