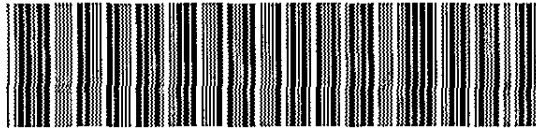

**ARTICLES OF INCORPORATION  
OF  
SUREBOX TRADING INC.**

The undersigned incorporator, being one (1) in number, for the purpose of becoming a body corporation hereby adopt the following Articles of Incorporation.

**ARTICLE I: NAME**

The name of the corporation shall be SUREBOX TRADING INC., hereinafter referred to as the "Corporation." The registered office and principal place of business of this corporation shall be at 410 Tallow Tree Drive, Pensacola, Florida 32506.

**ARTICLE II: DURATION**

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Secretary of State.

**ARTICLE III: PURPOSE**

The Corporation is organized for the purpose of engaging in the business of packaging and shipping non-perishable goods, and for the purpose of transacting any or all other lawful business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

**ARTICLE IV: CAPITAL STOCK**

The aggregate number of shares of stock said corporation is authorized to have outstanding at any one time shall be 1,00 shares of voting common stock at \$1.00 par value. It is stipulated that the total authorized capital of this corporation shall be valued at one hundred dollars (\$100.00) divided into 100 shares at \$1.00 par value per share, all of which may be outstanding at any time when appropriately and lawfully issued. The amount of capital stock outstanding this corporation will begin business is set at 100 shares (\$100.00).

**ARTICLE V: PREEMPTIVE RIGHTS**

Every shareholder, upon the sale of any shares or securities of the corporation convertible into or carrying a right to subscribe to shares of this corporation of the same kind, class, or series as that which the person holds, shall have the right to purchase his pro rata share at the price at which it is offered to others,

**ARTICLE VI: INITIAL REGISTERED OFFICE AND AGENT**

The principal office and street address of the Corporation is: 410 Tallow Tree Drive, Pensacola, Florida 32506.

The name of the registered agent of the corporation is: Jessie C. Sevilla, and the street office address of such corporation is: 410 Tallow Tree Drive, Pensacola, Florida 32506..

#### ARTICLE VII: INITIAL BOARD OF DIRECTORS AND OFFICERS

The number of directors of said corporation is hereby fixed at no more than five. The number of directors to be chosen for any year is determined by the stockholders at the annual meeting for the election of directors. In provision the number of members of the Board of Directors shall consist of one member until the first annual stockholders' meeting.

The officers and board of directors are subject to the provision of the Articles of Incorporation, the by-laws of this corporation, and the laws of the State of Florida. They shall hold office for the first year of service of the corporation until successors are elected. The following are the qualified and elected directors and officers of the corporation for the first year:


ARTICLE X: BY-LAWS

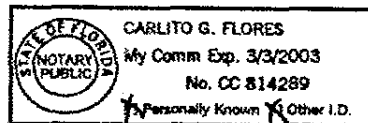

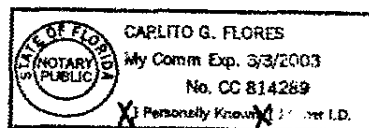


