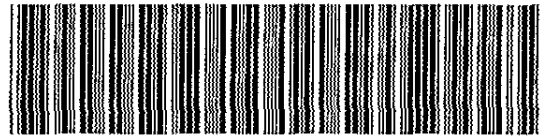

ARTICLE I.

NAME: The name of this corporation is SOUTHERN DEVELOPMENT OF  
NORTHWEST FLORIDA, INC.

ARTICLE II.

DURATION: This corporation shall exist perpetually commencing on the date and  
execution of these Articles.

ARTICLE III.



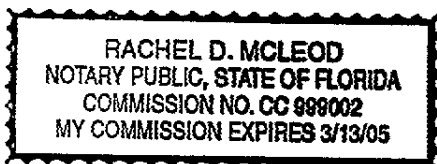
