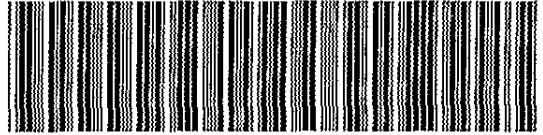




**ARTICLE VII. INDEMNIFICATION**

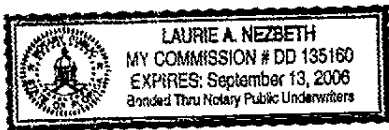
