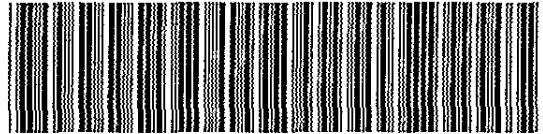

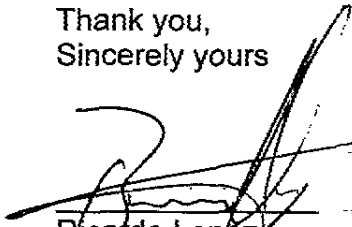

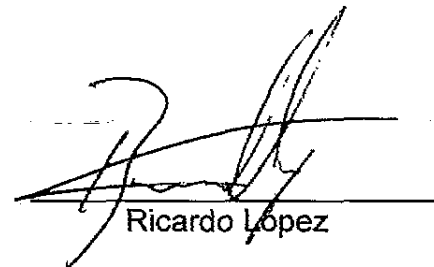
ARTICLE VIII PRE-EMPTIVE RIGHTS

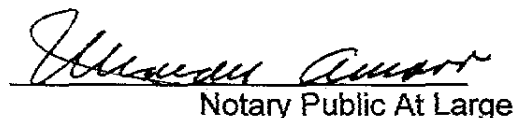

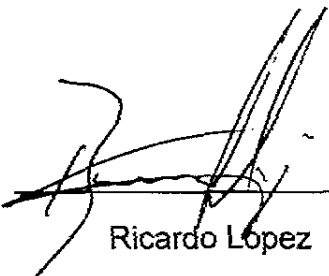
