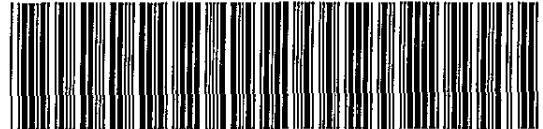



ARTICLE I - NAME

The name of this Corporation is Klemento, Inc., and the principal business and mailing address of the Corporation is 1630 Avoca Place, Jacksonville, Florida 32207.

ARTICLE II - COMMENCEMENT AND DURATION

Pursuant to Section 607.0203, Florida Statutes, this Corporation shall commence upon the date of execution of these Articles of Incorporation. This Corporation shall have perpetual existence.

The number of Directors constituting the initial Board of Directors of this Corporation shall be two(2) and the name and address of the persons who are to serve as the members thereof are:






