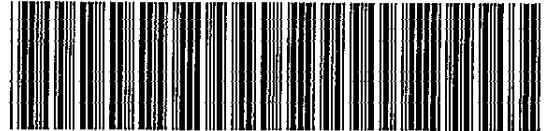

**ARTICLES OF INCORPORATION
OF

The undersigned incorporator hereby forms a for profit corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

ARTICLE II - NATURE OF BUSINESS

This corporation shall engage or transact in any and all lawful activities or business permitted under the laws of the United States of America and the State of Florida; including, without limitation, all activities relating to the purchase and sale of airplanes, and related aviation activities.

ARTICLE III - CAPITAL STOCK
