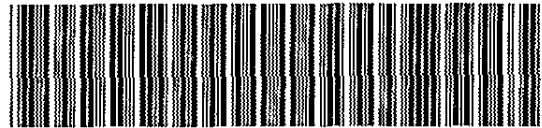

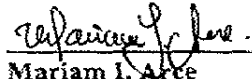

ARTICLE X - AMENDMENT

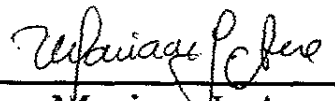
