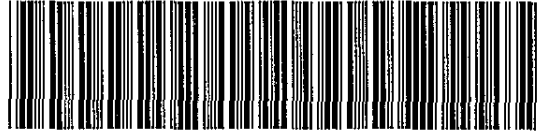



ARTICLE II - COMMENCEMENT AND DURATION




