ARTICLES OF INCORPORATION

FOR

LISTEN UP, INC.

ARTICLE I

The name of the corporation is: LISTEN UP, INC. The mailing address of the corporation is: 528 Coconut Isle Drive, Fort Lauderdale, FL 33301.

ARTICLE II
