

ARTICLES OF INCORPORATION OF EQUITY INVESTORS GROUP, INC.

In compliance with the requirements of F. S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

<u>Article I</u> Name of Corporation

The name of the corporation (the "Corporation") is Equity Investors Group, Inc.

Article II Principal Office

The principal place of business and the mailing address of the Corporation is: 11 Racetrack Road, N.E., Suite F-4, Ft. Walton Beach, FL 32547.

Article III Authorized Shares
