The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following articles of incorporation:

# **ARTICLE I**

The name of this corporation shall be: Dale W. Henning's Yards of Pleasure, Inc.

### **ARTICLE II**

The duration of the corporation shall be perpetual.

## ARTICLE III
