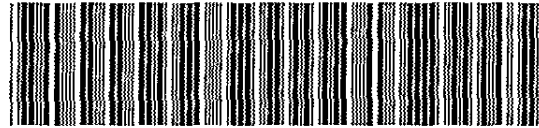

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**Article I**

The name of the Corporation ("Corporation") is TRI-COUNTY AIRCRAFT RENTAL AND AIR SERVICES, INC.

**Article II**

The existence of the Corporation shall begin on the date these articles of incorporation are filed with the Department of State.

**Article III**


