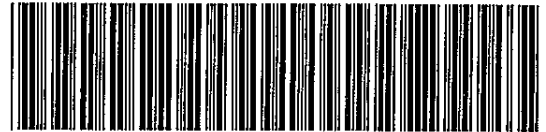

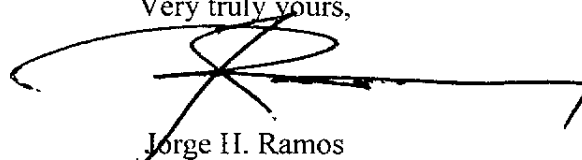

ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF

MACHADO/GARCIA-SERRA PUBLICIDAD, INC.

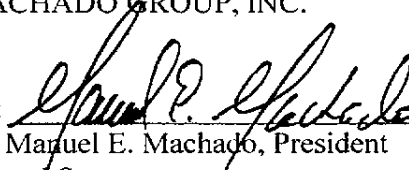
II. The foregoing amendment was adopted on 5 April 2004 by a joint unanimous consent of all the shareholders and all directors of the Corporation.
