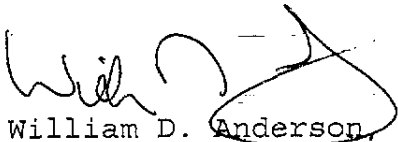

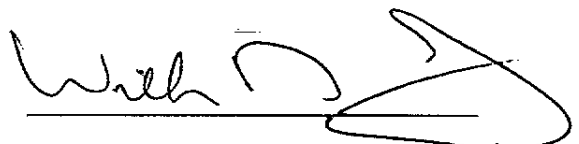
ARTICLE VII
