## ARTICLES OF INCORPORATION

For  
Teri Arbogast, P.A.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

### ARTICLE I: NAME

The name of the Corporation is Teri Arbogast, P.A. Principal place of business is 462 Barbri Lane, Davis, FL 33325.

### ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.
