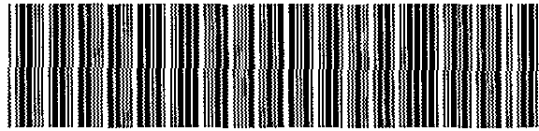

ARTICLE I.

CORPORATE NAME

The name of the corporation is LAS VEGAS FLOWERS, INC.

NATURE OF CORPORATE BUSINESS

The purpose is to engage in the purchase and distribution of dry and natural flowers, plants, vases and accessories, and the doing of any other business and contracting work incidental to or connected with such work, including demotion. To purchase or otherwise acquire, sell, import, export, distribute and deal in goods, wares, services, merchandise and materials of any kind and description. The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibit in the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for the furtherance of the corporate objectives expressed above.

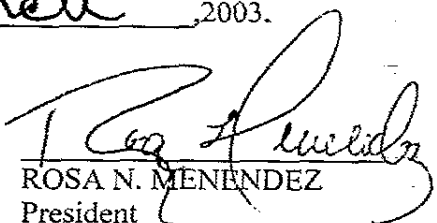
