The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be:

The principal place of business of this corporation shall be 11711 Wesson Circle East, Tampa, FL 33618.

**ARTICLE II. NATURE OF BUSINESS**

The date that the corporation existence shall begin shall be the date of filing of the Articles of Incorporation with the Secretary of State, State of Florida.



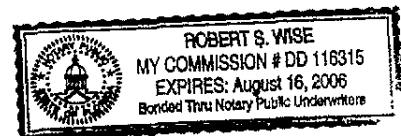
