To whom it may concern:

The following is to State that My Corporation NDoncell, INC sent to the Division of Corporation of Florida Department of State the payment of U\$150.00 (one hundred and fifty dollars) on April 25<sup>th</sup>, 2006 with money order # 55210572021. We called to investigate if the payment was cashed after receiving a letter on April 16<sup>th</sup>, 2007 in the mail from Florida Department of State saying the would not accept our pay for this year of U\$150.00 (one hundred and fifty dollars) that was sent on April 9<sup>th</sup>, 2007 because we owed U\$300.00 (three hundred dollars) for last years payment that was not received, we then sent two U\$150.00 (one hundred and fifty dollars) payment one dated April 19<sup>th</sup>, 2007 and another dated April 23<sup>th</sup>, 2007. Then we received another letter on May 7<sup>th</sup>, 2007 from the Florida Department of State Division of Corporation, stating that they where returning our pay of U\$300.00 (three hundred dollars) because we had to pay the fees to reinstate the Corporation are as follows U\$600.00 (six hundred dollars) reinstatement fee, U\$61.25 (sixty one dollars with twenty five cents) filing fee per year 2006 through the year, U\$88.75 (eighty eight dollars with seventy five cents) corporate supplemental fee for the years 1992 forward.

Therefore, the total fee was U\$900.00 (nine hundred dollars) add an additional U\$8.75 (eight dollars with seventy five cents) for each certificate of status request.

With all this now it seems we are owing more the four times what we originally owed. This is why we are requesting our penalties waved now that we have proven that we sent the payment on time but was never cashed by Florida Department of State Division of Corporation and they failed to report to us that the first payment was never received. We received a letter dated May 23<sup>th</sup>, 2006 with the letter dated May 7<sup>th</sup>, 2007.

We are doing this request with such a late date because we have just moved and where looking for all the paper work to prove our payment was done on time.
