## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

Four Seasons 3007, Inc. a Florida corporation

This Amendment shall be binding upon all of the Shareholders, Directors and Officers of the Corporation and their respective legal representatives, heirs, successors and assigns.
