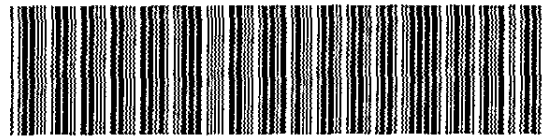



The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the Florida Professional Service Corporation and Limited Liability Company Act and laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be:

Gary Kreitman, M.D., P.A.

**ARTICLE II. PRINCIPAL PLACE OF BUSINESS**

The principal place of business and mailing address of this corporation shall be 9150 S.W. 87th Avenue, Suite 100, Miami, FL 33176-2311.

**ARTICLE III. PURPOSE**

The general nature of the business to be transacted by this corporation is;

To engage in every phase and aspect of the business of rendering the same professional services to the public that a medical doctor, duly licensed under the laws of the State of Florida, is authorized to render;

To invest the funds of the corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and to own real and personal property necessary for the rendering of professional services;

lawful pursuit necessary or incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes or objects of the corporation.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of the corporation; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this corporation otherwise permitted by law.

#### ARTICLE VII. OFFICERS AND DIRECTORS




