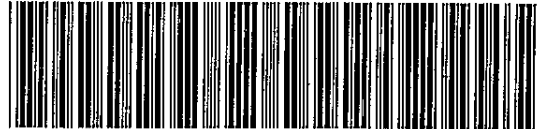

ARTICLES OF INCORPORATION

OF

DOYLE DEVELOPMENT COMPANY, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit, under the laws of the State of Florida.

ARTICLE I.

The name of this Corporation is DOYLE DEVELOPMENT COMPANY, INC.

ARTICLE II. NATURE OF BUSINESS.

The general character, purpose, and nature of business to be transacted by this Corporation is: provide transportation of materials, equipment, parts, supplies, land clearing and sale of fill dirt and any other business legally permitted under the laws of the state of Florida.

ARTICLE III. CAPITOL STOCK.

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is 1000 shares of common stock, each share having a par value of \$1.00. 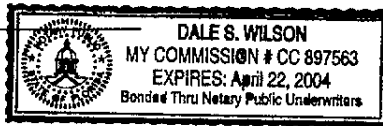
