

# ARTICLES OF INCORPORATION

The undersigned, acting as incorporations of a Corporation pursuant to Chapter 607, Florida Statutes, adopt(s) the following Articles of Incorporation for such Corporation.

### ARTICLE I

The name of this Corporation is: TRESCELLO ENTERPRISES INC.

### ARTICLE II

The period of the duration of the Corporation shall be "Perpetual" unless dissolved according to law. Existence shall commence upon filing with the Secretary of State.
