ARTICLES OF INCORPORATION OF INSTA MARKING IDENTIFICATION, INC.

ARTICLE I. NAME

The name of this corporation shall be Insta Marking Identification, Inc.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Secretary of State. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE

This corporation is being organized for the purpose of engaging in retail business and engaging in the transaction of any and all business activities permitted under the laws of Florida and the United States Of America.
