ARTICLE I. NAME

The name of this corporation is
G.S. DREAM BUILDERS, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.



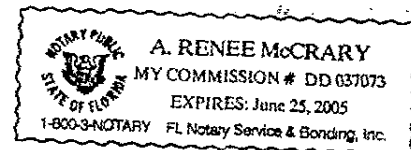


