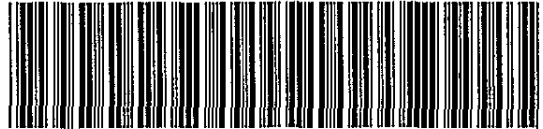

ARTICLES OF INCORPORATION
For
'Taste of the Islands' Corporation

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

• **ARTICLE I**

The name of this corporation shall be *Taste of the Islands Corporation* and it's initial address shall be 1275 SW 46th Ave #2407, Pompano Beach FL, 33069.

• **ARTICLE II**

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States of America, the State of Florida, or any other state, country, territory, or nation.

• **ARTICLE III**

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

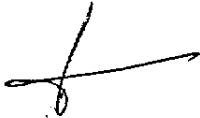

• **ARTICLE XI**

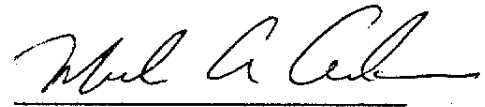
This corporation shall indemnify and insure its officers and directors to the fullest extent permitted by law either now or hereafter.

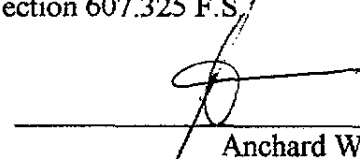

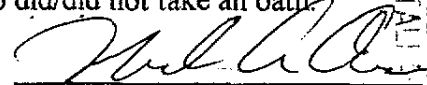
