The undersigned subscriber to these articles of incorporation, who is a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I.

Name

The name of this corporation is JEFF WAYNE & ASSOCIATES, INC.. The mailing address of the corporation is 1649 Seminole Drive, Sarasota, Florida 34239.

ARTICLE II.

Term of Existence

The date when corporate existence shall commence shall be the date of filing, and the corporation shall have perpetual existence thereafter.

ARTICLE III.

Nature of Business

This corporation is organized to engage in the business of any and all lawful businesses.

ARTICLE IV.

<u>Powers</u>
