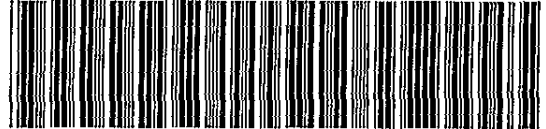

ARTICLES OF INCORPORATION
OF
