

ARTICLES OF INCORPORATION
OF
BUTLER MORSE RESTORATION SERVICES, INC.

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is BUTLER MORSE RESTORATION SERVICES, INC. Its principal office and mailing address is 151 S.E. 15th Road, Brickell East, 10th Floor, Miami, Florida 33129.

ARTICLE II - DURATION

The effective date of this Corporation shall be March 14, 2003, and it shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in concrete restoration and waterproofing services, and related business activities, in accordance with Chapter 621, Florida Statutes, and any successor statute or law.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$.10 per share.

**ARTICLE V - INITIAL
REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of this Corporation shall be The Colonnade, Suite R-60, 2333 Ponce de Leon Boulevard, Coral Gables, Florida 33134, and the initial registered agent of this Corporation at such office shall be Roland R. St. Louis, Jr., who upon accepting this designation agrees to comply with the provisions of Chapters 48 and 607, Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of three members. The number of director(s) may be increased or decreased from time to time by vote of the Board of Directors, but in no case shall the number of directors be less than one nor more than five. 

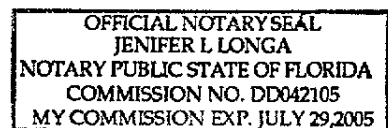


