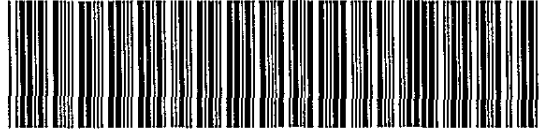

ARTICLE V - INCORPORATOR

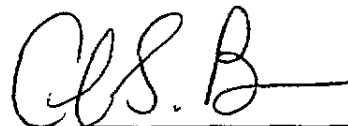
