**ARTICLES OF INCORPORATION
OF
ASK SOMEONE WHO CARES, INC.**

THE UNDERSIGNED, natural person(s) of legal age, acting as incorporator(s) for the purpose of forming a corporation under the laws of the State Florida adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is Ask Someone Who Cares, Inc.

ARTICLE II - DURATION

The period of its duration is perpetual.

ARTICLE III – PURPOSE (S)

The purpose(s) for which the corporation is organized are “To operate an Affordable Healthcare Referral Service Business, consistent with any other referral service activities of the Industry”. “And any other lawful business activity for which corporation may be incorporated under Chapter 607 of the Florida Statutes”.

ARTICLE IV – CAPITAL STOCK

The aggregate number of shares, which the corporation shall have authority to issue, is One Million, 1,000,000 shares of common stock having a par value of One Dollar (\$1.00) each.

Section 1 - Stated Capital: The sum of all the share of the corporation outstanding at any particular time shall be the capital of the corporation.

Section V - Preemptive Rights: There are no provision limiting or denying to shareholders The preemptive right to acquire additional treasury or corporate shares of the corporation.

The internal affairs of the corporation are governed by the “by-laws” which shall be established And approved by a majority of the directors at the First Meeting of the Board of Directors.

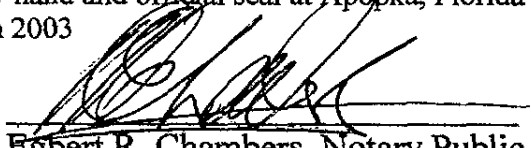

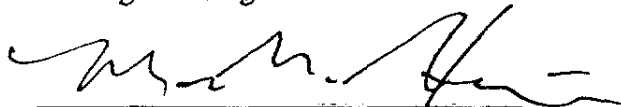
