ARTICLES OF INCORPORATION
OF
JANCO STORES, INC.

In compliance with the requirements of chapter 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Janco Stores, Inc.

ARTICLE II

The existence of the Corporation shall begin on the date the Articles of Incorporation are filed with the Secretary of State of Florida and shall be perpetual.

ARTICLE III

The nature of the business and of the purposes to be conducted and promoted by the Corporation is to engage solely in the activity of acting as the outside member of EXPREZIT! Convenience Stores, LLC, a Florida limited liability company ("Parent"), whose purpose is to:

(a) To own 100% of the membership units of (i) EXPREZIT! Convenience Stores 00-North Carolina, LLC, (ii) EXPREZIT! Convenience Stores 99-Florida, LLC, and (iii) EXPREZIT! Convenience Stores 98-Georgia, LLC (collectively referred to hereinafter as the "Subsidiaries").

(b) To exercise all powers enumerated in the Florida Limited Liability Act necessary or convenient to the conduct, promotion or attainment of the business or purposes otherwise set forth herein.

The nature of the Subsidiaries' business and of the purposes to be conducted and promoted by the Subsidiaries, is to engage solely in the following activities:

(a) To acquire certain parcels of real property, together with all improvements located thereon, in the locations set forth on Exhibit A attached hereto (the "Property");

(b) To own, hold, sell, assign, transfer, operate, lease, mortgage, pledge and otherwise deal with the Property; and

(c) To exercise all powers enumerated in the Florida Limited Liability Act necessary or convenient to the conduct, promotion or attainment of the business or purposes otherwise set forth herein.

The Corporation shall exercise all powers enumerated in the Florida Business Corporations Act necessary or convenient to the conduct, promotion or attainment of the business or purposes otherwise set forth herein.

ARTICLE IV

The Corporation shall only incur or cause the Parent and Subsidiaries to only incur indebtedness in an amount necessary to acquire, operate and maintain the Property.

For so long as any mortgage lien in favor of LaSalle National Bank, a national banking association now known as LaSalle Bank National Association, as Trustee under that certain Loan Pool Pooling & Servicing Agreement dated as of July 7, 1998, LaSalle National Bank, a national banking association now known as LaSalle Bank National Association, as Loan Pool Trustee under that certain Loan Pool Pooling and Servicing Agreement, in trust for the EMAC 1999-1 Loan Pool Certificateholders, dated as of March 26, 1999, or LaSalle Bank National Association, as Loan Pool Trustee under that certain Loan Pool Pooling & Servicing Agreement dated as of February 1, 2000, or any of their respective successors or assigns (collectively, the "First Mortgages") exists on any portion of the Property, the Corporation shall not and shall not cause or permit the Parent or any of the Subsidiaries to incur, assume, or guaranty any other indebtedness.

For so long as any of the First Mortgages exists on any portion of the Property, the Corporation shall not and shall not cause or permit the Parent or any of the Subsidiaries to dissolve or liquidate, or consolidate or merge with or into any other entity, or convey or transfer its properties and assets substantially as an entirety or transfer any of its beneficial interests to any entity.

For so long as any of the First Mortgages exists on any portion of the Property, the Corporation shall not voluntarily commence a case with respect to itself or cause or permit the Parent or any of the Subsidiaries to voluntarily commence a case with respect to itself, as debtor, under the Federal Bankruptcy Code or any similar federal or state statute without the unanimous consent of the board of directors.

For so long as any of the First Mortgages exists on any portion of the Property, without first obtaining approval of the mortgagee or mortgagees holding the First Mortgages on any portion of the Property: (i) no material amendment to the certificate of incorporation or to the Corporation's bylaws nor to the articles of organization or the operating agreements of the Parent or any of the Subsidiaries may be made without first obtaining approval of the mortgagee or mortgagees holding the First Mortgages on any portion of the Property; (ii) in the event the existence of the Parent or any of the Subsidiaries is not continued, the Corporation shall not cause the Parent or any of the Subsidiaries to liquidate; and (iii) the Corporation shall not voluntarily cease to be a member of the Parent.

ARTICLE V

The street address of the principal office of the Corporation is 6330 Quadrangle Drive, Chapel Hill, North Carolina 27517.

ARTICLE VI

The maximum number of shares this Corporation is authorized to issue is 100, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE VII

For so long as any of the First Mortgages exist on any portion of the Property, in order to preserve and ensure its separate and distinct corporate identity, in addition to the other provisions set forth in this certificate of incorporation, the Corporation shall conduct its affairs in accordance with the following provisions:

- (a) It shall allocate fairly and reasonably any overhead for office space shared with any parent or Affiliate.
- (b) It shall maintain corporate records and books of account separate from those of any parent or Affiliate.
- (c) Its board of directors shall hold appropriate meetings (or act by unanimous consent) to authorize all appropriate corporate action.
- (d) It shall observe all corporate formalities.
- (e) It shall not commingle assets with those of any parent or Affiliate.
- (f) It shall conduct its own business in its own name.
- (g) It shall maintain financial statements separate from any parent or Affiliate.
- (h) It shall pay any liabilities out of its own funds, including salaries of any employees, not funds of any parent or Affiliate.
- (i) It shall not guarantee or become obligated for the debts of any other entity, including any parent or Affiliate, or hold out its credit as being available to satisfy the obligations of others.
- (j) It shall use stationery, invoices and checks separate from any parent or Affiliate.

- (k) It shall not pledge its assets for the benefit of any other entity, including any parent or Affiliate.
- (l) It shall hold itself out as an entity separate from any parent or Affiliate.

For purposes of this Article VII, the following terms shall have the following meanings:

"Affiliate" means any Person controlling or controlled by or under common control with the parent, including, without limitation: (i) any Person who has a familial relationship, by blood, marriage or otherwise with any director, officer or employee of the corporation, its parent, or any affiliate thereof; and (ii) any Person who receives compensation for administrative, legal or accounting services from this Corporation, its parent or any affiliate. For purposes of this definition, "control" when used with respect to any specified Person, means the power to direct the management and policies of such Person, directly or indirectly, whether through the ownership of voting securities, by contract or otherwise; and the terms "controlling" and "controlled" have meanings correlative to the foregoing.

"Person" means any individual, corporation, partnership, limited liability company, joint venture, association, joint stock company, trust (including any beneficiary thereof), unincorporated organization, or governmental or any agency or political subdivision thereof.

ARTICLE VIII

When voting on matters concerning the Parent or Subsidiaries, notwithstanding that the Parent or the Subsidiaries are not then insolvent, the Corporation shall take into account the interest of the Parent's and Subsidiaries' creditors, as well as those of their respective members.

ARTICLE IX

The initial street address of the Corporation's registered office is 501 Commendancia Street, Pensacola, Florida 32501. The initial registered agent for the Corporation at that address is David E. Hightower.

ARTICLE X

The initial board of directors shall consist of two members. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than two. At all times at which the directors of the Corporation shall take, or shall be required to take, any action in such capacity and until such time as all obligations secured by the First Mortgages have been paid in full, there shall be at least one Independent Director. An "Independent Director" shall mean an individual who, except in his or her capacity as an Independent Director of the Corporation, is not, and has not been during the five years immediately before such individual's appointment as an Independent Director, (i) a stockholder, director, officer or employee of the Corporation, the Parent, Subsidiaries, or affiliates of any of them, (ii) affiliated with a significant customer or supplier of the Corporation, the Parent,

Subsidiaries, or affiliates of any of them; or (iii) a spouse, parent, sibling or child of any individual described by (i) or (ii) above.

With the consent of the stockholders of the Corporation, which consent the stockholders believe to be in the best interest of the stockholders and the Corporation, no Independent Director shall, with regard to any action to be taken under or in connection with these Articles, owe a fiduciary duty or other obligation to the stockholders nor to any successor stockholders (except as may specifically be required by the statutory law of any applicable jurisdiction), and every stockholder, including each successor stockholder, shall consent to the foregoing by virtue of such stockholder's purchase of shares of capital stock of the Corporation, no further act or deed of any stockholder being required to evidence such consent. Instead, such Independent Director's fiduciary duty and other obligations with regard to such action under or in connection with these Articles shall be owed to the Corporation (including its creditors). In addition, no Independent Director may be removed unless his or her successor has been elected.

ARTICLE XI

ARTICLE XII

The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law. Notwithstanding the foregoing, any indemnification of the Corporation's directors and officers shall be fully subordinated to any obligations respecting the Parent, Subsidiaries or the Property (including, without limitation, the First Mortgages) and such indemnification shall not constitute a claim against the Corporation or the Parent or Subsidiaries in the event that cash flow in excess of amounts necessary to pay holders of such obligations is insufficient to pay such obligations.

ARTICLE XIII

Pursuant to section 607.0203, Florida Statutes, the corporation's effective date shall be March 18, 2003.
