ARTICLES OF INCORPORATION

OF

ISO Parts Incorporated

FIRST. The name of the corporation is ISO Parts Incorporated.

SECOND. The street address of the initial principal office of the corporation is 416 Stonehenge Circle, Rockledge, Florida 32955.

THIRD. The total number of shares of all classes of stock which the corporation shall have authority to issue is 1,500, of which 1,000 shares of par value \$0.001 per share shall be designated as Common Stock and 500 shares of par value \$0.001 shall be designated as Preferred Stock. 
