

## ARTICLES OF INCORPORATION OF SWC INVESTMENTS, INC.

#### ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is SWC INVESTMENTS, INC. and its principal place of business shall be located at 4210 W. Spruce Street, Suite 202, Tampa, Florida 33607-4127.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

#### ARTICLE III - PURPOSE
