NAME, ADDRESS AND AGENT

ARTICLE II

NATURE OF BUSINESS

Section I. The general nature of the business and objects and purposes to be transacted, promoted and carried on are to do any and all things hereinafter mentioned, as fully and to the same extent as natural persons might or could do, viz:

- a. To carry on business in the United States or any foreign -country or countries, to buy, sell, import, export, lease, sub-lease, hol
 procure, transport, manufacture, acquire and deal generally, both whole
