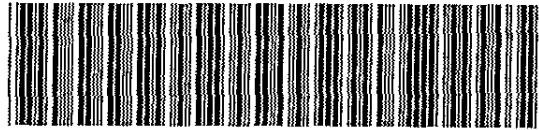

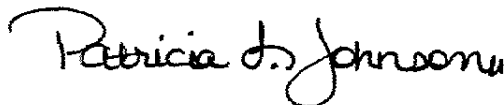

ARTICLE I - NAME AND ADDRESS OF BUSINESS

The name of the corporation is GFF, INC. The principal address of the corporation is 5340 Highway 98 North, Lakeland, Florida 33809.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

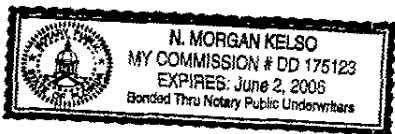

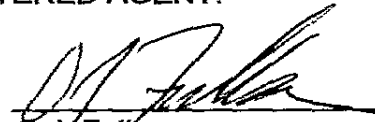
