

# ARTICLES OF INCORPORATION OF GFF, INC.



#### **ARTICLE 1 - NAME AND ADDRESS OF BUSINESS**

The name of the corporation is GFF, INC. The principal address of the corporation is 5340 Highway 98 North, Lakeland, Florida 33809.

#### <u>ARTICLE II - NATURE OF BUSINESS</u>

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.


