#### ARTICLES OF INCORPORATION

The undersigned acting as Incorporator and Initial Director of <u>FUCINI ELECTRIC OF</u>

<u>SOUTH FLORIDA, INC.</u>, under the Florida Business Corporations Act, adopts the following

Articles of Incorporation:

#### ARTICLE 1 - NAME

The name of this corporation shall be FUCINI ELECTRIC OF SOUTH FLORIDA, INC.

#### ARTICLE II - PURPOSE

The general nature of the business to be transacted by this corporation shall be to engage in any and all lawful business under the laws of the State of Florida.

#### ARTICLE III - PRINCIPAL OFFICE

## ARTICLE IV - CAPITAL STOCK

having not less than the minimum number of votes with respect to each voting group that would be necessary to authorize or take such action at a meeting at which all voting groups and shares entitled to vote thereon were present and voted. Prompt notice of the taking of the corporate action without a meeting by less than unanimous written consent shall be given to shareholders who have not consented in writing or who are not entitled to vote on the action. Any action required or permitted by law to be taken at a board of directors' meeting or committee meeting may be taken without a meeting if the action is taken and consented to in writing by all the members of the board or committee.

#### ARTICLE XIII - INDEMNIFICATION

This corporation shall indemnify every person who is or was threatened to be made a party to any action, suit or proceeding, whether civil, criminal, administrative or investigative by reason of the fact that he or she is or was a director or officer of this corporation against expenses (including attorneys' fees), judgments, fines and amounts paid in settlement, actually and reasonably incurred by him or her in connection with such action, suit or proceeding, (except in cases involving gross negligence or willful misconduct in the performance of his or her duties), to the full extent permitted by applicable law.
