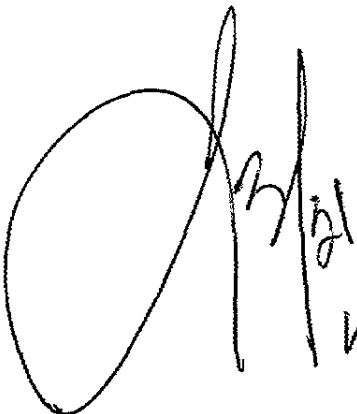

AMENDMENTS

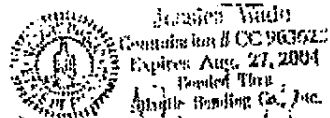
