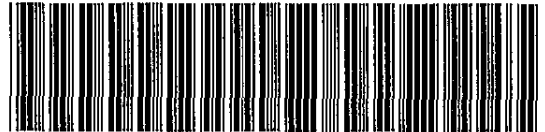

2. The foregoing Amendment was adopted by all shareholders, officers and directors of this corporation on the 18 day of MARCH, 2005.


