

ARTICLES OF INCORPORATION

OF

LS Boca, Inc.

ARTICLE I - NAME.

The name of this corporation is LS Boca, Inc.

ARTICLE II - DURATION.

This corporation is to have perpetual existence beginning with the date of subscription and acknowledgment of these Articles of Incorporation which is March 19, 2003.
