ARTICLES OF CORPORATION

OF

Le Jeune Supper Club, Inc.

ARTICLE 1 - NAME

The name of this corporation is:

Le Jeune Supper Club, Inc.

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence upon filing.

ARTICLE III - PURPOSE
