#### ARTICLES OF INCORPORATION

OF

#### SKYSAIL VENTURES, INC.

The undersigned subscriber, a natural person competent to contract, desires to form a corporation under the laws of the State of Florida, and hereby adopts the following.

Articles of Incorporation for such corporation.

#### ARTICLE I. NAME

The name of the corporation is:

#### SKYSAIL VENTURES, INC.

#### ARTICLE II. NATURE OF BUSINESS
