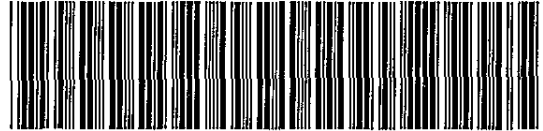

OF
