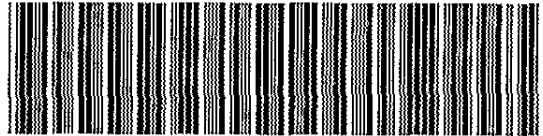

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is NAHA LAXMI, INC., and the principal address and principal place of business is 9142 HIGHLAND RIDGE WAY, TAMPA, FLORIDA 33647-2277.

ARTICLE II - REGISTERED OFFICE AND AGENT
