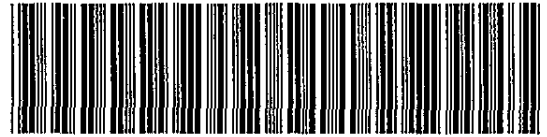


GENERAL PURPOSES






