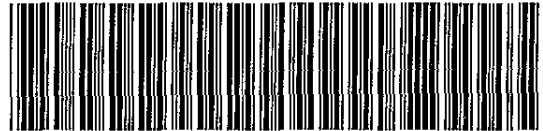

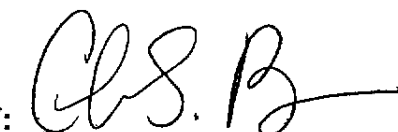
The purpose of the corporation is to conduct any business enterprise not contrary to law.
