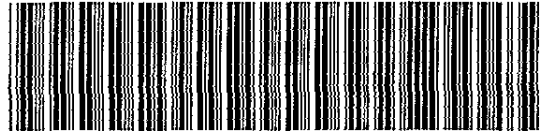

1. The name of the incorporation is: ericaire books, Inc.
2. The principal place of business and mailing address of the corporation is: 103 N. Oceanaire Terrace, Ormond Beach, Florida 32176.
3. The corporation shall have the authority to issue 10,000 shares of common stock, in one class only.
