

ARTICLES OF INCORPORATION

The undersigned incorporator to these Articles of Incorporation, hereby forms a Not For Profit Corporation for profit pursuant to the Corporations Act and other laws of the State of Florida.

ARTICLE I NAME

The name of the corporation shall be: Emerald Society of Coconut Grove, Inc. (the "Corporation").

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS

The principal place of business and mailing address of the Corporation shall be:

ARTICLE III CORPORATE PURPOSE

The Corporation is hereby organized for the charitable purpose, beneficial to the public interest, of promoting Irish-American society, culture, and education, and any activities in support thereof, such as the right to: (a) adopt and use a corporate seal, (b) adopt, amend and repeal bylaws; (c) do business in other states; (d) make donations to non-profit organizations; (e) operate pension plans for employees; (f) make loans to shareholders, directors and employees pursuant to Florida law; and (g) participate in joint ventures with other persons, and trusts and corporations. The Corporation will not substantially engage in activities that are not related to furthering the charitable purposes for which the Corporation was formed, or bestow special benefits on particular individuals rather than the public at large.
